It has also been reported that copper poisoning has lead to hemolytic anemia and accelerates arteriosclerosis., Blood disorders, Liver injury may occur., Damage to the lungs., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
