Fluoxymesterone is a member of the 17-alpha-alkylandrogen family. Prolonged use of this group has been associated with development of hepatic adenomas, hepatocellular carcinoma, peliosis hepatis, cholestatic hepatitis and jaundice. Women should be observed for signs of virilization. When administered to a pregnant woman, androgens can cause virilization of external genitalia of the female fetus. Can cause suppression of blood clotting factors. Other symptoms of exposure include hirsutism, male pattern baldness, seborrhea, acne, hypersensitivity (including skin manifestations and anaphylactoid reactions), retention of sodium, water, chloride, calcium, potassium, and inorganic phosphates., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
